- ▲ Fed Rate Hike – The Federal Reserve slows rate hikes to 25 basis points on Wednesday, moving the target benchmark to a range of 4.5% to 4.75%.
- Adani group – Adani Enterprises has called off the FPO and will refund the money to the investors. The private banking wing of Credit Suisse has stopped accepting bonds of certain Adani group entities, and has assigned a zero lending value to their bonds.
- ▼ Adani group – Adani Enterprises has called off the FPO and will refund the money to the investors. The private banking wing of Credit Suisse has stopped accepting bonds of certain Adani group entities, and has assigned a zero lending value to their bonds.
- ▲ Britannia - the company reported a 152% YoY rise in consolidated net profit to Rs. 932.40 crore in Q3FY23, compared to Rs. 369.18 crore recorded in Q3FY22. The revenue from operations in Q3FY23 stood at Rs. 4,196.80 crore, up 17.39% YoY from Rs. 3,574.98 crore.
- ▲ Mahindra & Mahindra - The total auto sales for January, 2023 was recorded at 64,335 units. The company has sold 32,915 units of vehicles in the Utility Vehicles segment and 33,040 units of Passenger Vehicles.
- ▼ Bajaj Auto - The company reported domestic sales of 1,40,428 units for January, 2023, a 4% increase from 1,35,496 units sold in January, 2022. The exports were recorded at 1,00,679 units for January, 2023, down 46% from 1,87,934 units exported in January, 2022.
- ▼ Jubilant Foodworks - The consolidated net profit of the company stood at Rs. 80.4 crore in Q3FY23, down 40% YoY. The revenue from operations for Q3FY23 was registered at Rs. 1,332 crore, an increase of 10% YoY.
- ▼ Whirlpool - The standalone net profit of the company plunged 74% YoY to Rs. 10.7 crore in Q3FY23. The standalone revenue from operations in Q3FY23 dropped by 18.3% YoY to Rs. 1,172 crore.

Trading Guideline

- ❖ This model is based on the premise that the PIVOT is the most important price level that decides the intraday trend. Much like how the door or a window hangs by a hinge and sways in the wind, the intraday trend also hangs by this PIVOT LEVEL and swings because of the Demand supply, volatility and market sentiments prevailing in the market. Hence its importance in intraday trading.
- ❖ Wait for the market price to stabilize after opening the first 30 minutes of trading.
- ❖ Opening Price is considered around the close of the Previousday. Avoid BUYING if prices open abnormally high and avoid selling if prices open too low.
- ❖ If the market price is stable above the pivot level after 20-30 minutes of opening, then GO LONG and book profit near the resistant level (R1 & R2).
- ❖ If the market price is stable below the pivot level after 20-30 minutes of opening, then GO SHORT and book profit near the support level (S1 & S2)

Stop Loss

Since you are aware of the 'potential returns at the time of initiating an intraday trade (difference between the entry price and profit targets), you should set up an appropriate STOP LOSS around 1% above / below of the trade price or a level comfortable to you, to protect yourself if the market turns and goes against you.

Alternate Strategy

If you have already initiated a trade with clear-cut profit targets and a stop loss level, and find during the course of the trading day that the market turns and goes the other way and crosses the TREND LEVEL, then trade again: For instance, if your first trade was a LONG trade and the market price drops through the TREND LEVEL to lower price levels, then GO SHORT and if your first trade was a SHORT trade and the market price rises through the TREND LEVEL to higher price levels, then GO LONG.

S1, S2 are the immediate support levels.

R1, R2 are the immediate resistance levels.
